#2. Tuition Policy

Tuition fees are based on 30 lessons per year per student and have been broken down into monthly payments. I understand that if the Student's tuition is not paid in full on the first lesson of the month, I will pay a \$20.00 late fee. All tuition and late fees must be paid before a Student is allowed to perform in any shows or recitals. I also understand that I am responsible for all tuition until I notify the office staff of my intention to cease lessons IN WRITING. Any time slot being held for a student must be paid as regular tuition in full.

#3. Absence / Make Up Policy

If you are going to miss a lesson, please try to give someone in our office a 24-hour notice. If you know in advance that you will be missing a specific lesson – please let your teacher know and a make-up lesson can be arranged at that time. Students are allowed two make-up lessons per year. These make up lessons must be scheduled within 30 days of the original date of your missed lesson. We do not provide make up lessons for missed make up lessons. If you give less than a 24-hour notice, there will not be a make-up lesson allowed, as the teacher has to be paid for being present at lessons that are canceled on short notice.

We, The Burt Wood School of Performing Arts, as the Managers/liaison between you and the casting companies, maintain the right to receive 10% of all work acquired through or because of this office. This includes but is not limited to commercial, movie, industrial, live theatre, and voice over work. This also includes auditions calls scheduled through your private residence due to casting efforts through our office. We reserve the right to publish or print any testimonials from your child/family or photos of your child with regards to our school newsletter, web site, and state wide newspapers.
